## ASK

1

"DO YOU HAVE A WARRANT SIGNED BY A JUDGE?"  
**REPLY: YES**

**SAY:** "CAN YOU PLEASE, PASS IT UNDER THE DOOR OR SHOW IT TO ME THROUGH THE WINDOW?"

## IDENTIFY

KNOW THE DIFFERENCE BETWEEN AN ICE WARRANT AND AN ARREST

**NON-VALID WARRANT:** SIGNED BY AN ICE AGENT, NOT BY A JUDGE OR MAGISTRATE. SAYS "AUTHORIZED IMMIGRATION OFFICER" BELOW THE SIGNATURE LINE.

**VALID WARRANT:** SIGNED BY "U.S. MAGISTRATE JUDGE" UNDER THE SIGNATURE LINE.

## IF IT IS VALID

1. CHECK THAT YOUR NAME IS ON THE WARRANT.

2. IF VALID, THE PERSON NAMED ON THE WARRANT SHOULD LEAVE THE HOUSE TO SPEAK WITH ICE. OTHERS IN THE HOME SHOULD STAY INSIDE.

5. YOU CAN ASK FOR A BOND HEARING
